Old Business:

Larry heard from Dale regarding the Tamaqua Fall Car Show. It has been cancelled due to some issues with the borough and the town regarding congestion and handicap access. They have returned all the vendor monies and cancelled everything. They plan to cordon off a 4-block area for next year's Tamaqua festivals. Larry is going to talk to Dale regarding our position. We need electricity and room for parking the cars. Steve also brought up the quality of trophies they supplied. Larry said he would talk to Dale and see if we can improve on them.

Steve stated that the dash plaques for the September 30th show are done and he brought a sample to show everyone. Mary did not want a car on there since the church was paying for them but put the Jukebox Cruisers logo on as the sponsor. They turned out very nice. Mary made a list of what the church people are doing and Steve has a list of what we need to do. Voting will go to spectators. Trophies are really nice. There will be a pizza vendor and breakfast sandwiches. The baskets are beautiful for the Chinese Auction. Joe Boyle is taking care of Lansford Alive car cruise and we are very grateful to him to go and represent the Club. From now on, the Lansford event will be a standing date for us in the future.

As of September 13th, we have 144 members. 134 members paid and 10 members unpaid. Evan Hartman emailed me and withdrew from club.

Tim is here and let us know that he is the contact for the website domain. He said we can probably use the PO Box for an address but we will need a contact phone number going forward. The credit card on file for the domain renewal and the web posting is Roger's and both are coming due soon. We should change the credit card billing to the club's card and reimburse Roger for any expense he may have incurred.

Tim also stated that he only ever received one request for posting a picture and it was recent. Larry reiterated that anyone wanting a photo posted to the website should go through "Contact Us" and he would handle it. Dave Kost suggested that a line should be put on the new member application to encourage photos of their vehicle(s) for possible future postings. He made a motion to make a change to the New Member application, Steve Berger seconded it. All were in favor and motion carried. This will be incorporated on the new member application rolling out this month. It will also be put in the Newsletter in January.

Tim asked if it was necessary to have all the cars listed on the member list spreadsheet. Larry as well as other members felt that it was important to have the members and their cars listed. It is the only place where this information is available.

There is nothing in the by-laws saying that members don't have to pay. Larry has a copy and thinks that the by-laws were previously superseded. All members must pay.

We received a donation of \$100 from Blockers Collision for our participation in running their 75th anniversary car show. We got good press with club member's pictures in the Times News newspaper.

T-shirt sales are still going strong. We just about recovered the initial cost already. Whatever is left in inventory will be pure profit. Another order will have to be placed soon. Larry will get together with Harry to determine what we want to order, maybe some long-sleeved shirts and V-necks, hoodies, etc. It was suggested to order less of the medium size and maybe add 3XL.

Mrs. Bush's flyer has been posted on the web site. It is a very nice show and all of the residents really enjoy it.

Jukebox Cruisers Car Club Member stickers are being handed out. It was announced at the Cruise that any member who did not receive one for each of their cars should come to the front table to get them. They are complimentary to all members. The sticker should be placed in the front window to identify our members.
